THINK ABOUT IT

Reports of medical research are not just automatically published by a journal. The process usually begins with the person who does the research (the investigator) selecting a particular journal in which he or she wants the research to be published. That investigator then submits a report of the research project to that journal; that manuscript is then assessed by the editorial board and several outside expert peer reviewers. The final decision to publish or not publish only occurs after communications between the investigator, the editorial board, and the peer reviewers.

Retraction Watch is an on-line service that posts notices of problems with scientific publications. In general, it alerts its readers to papers that have been retracted after publication because of some breach of scientific ethics. Examples of such breaches include authors who publish the same data twice or manipulate data from experiments. Recently a story appeared on this site dealing with a paper that was initially accepted by a journal and then withdrawn.

The British Medical Journal has some subsidiary journals including one known as BMJ Global Health. According to Retraction Watch, this journal received a paper that questioned the ethical underpinnings of a 20-year old trial that was done in India under the sponsorship of the US National Cancer Institute. The paper, written By Dr. Eric Suba and his colleagues, was based on documents that were obtained via the Freedom of Information Act. The paper was apparently published on-line on the BMJ Global Health website and the journal had even planned to release a press release about it.

However, the journal then changed its decision, removed the paper from its website, and informed Dr. Suba that it could not be published. What had happened was that, after accepting the paper, the journal sent it to their legal adviser. The journal subsequently decided that the allegations in the paper were significant

enough that BMJ would be opening itself to "legal action for defamation" and declined publication based on the "advice of our lawyer".

This story concerned me because of the veto power that the journal gave to its legal (non-scientific) staff. I have always believed that matters of scientific controversy need open and complete discussion, not suppression. An article that has cleared the hurdle of peer and editorial review should not be suppressed by legal bureaucrats. It has always been difficult for me to accept the practice of physicians ordering extra tests that do not make any difference to patients just to protect themselves in case of subsequent malpractice actions, so called "defensive medicine". It is even harder to accept editorial decisions not to publish papers because of "defensive journalism".
