THINK ABOUT IT

In 1984, a 24 year-old single mother of two children pled guilty to second degree murder. The crime occurred after her roommate told her that a man owed her some money and they then robbed him. During the event, this woman did hit the man over the head with a beer bottle and the roommate stabbed him multiple times. In exchange for her plea and for testifying against one of her co-defendants (and the story in the LA Times did use the plural, although the other perpetrators were not identified), the woman was offered a prison sentence of 7.5 years.

Unfortunately for her, the plea agreement was never put into writing. It was subsequently discovered in court that the law demanded a minimum sentence of 10 years and, when that fact was realized, she received the longer sentence. Her mother hired a lawyer to challenge the longer sentence; that lawyer was eventually successful in overturning the conviction and a new trial was ordered. The retrial occurred in 1994, shortly before she was to become eligible for parole after being in prison for nearly 10 years. The new trial turned out to be even more disastrous for her. When she was tried as a single defendant, she was found guilty of first degree murder and sentenced to life imprisonment. Thus, her co-defendants wound up with shorter sentences than she did.

The case has been reviewed on various occasions, most recently in 2016 in a federal appeals court. The three judges who heard the case that time ruled 2:1 that she had committed a "gruesome and senseless crime" and that the law dictated the penalty. However, the judges also thought that the subsequent sentencing events were troubling. These events included an initial denial by the prosecutor that any bargain had been offered, but a transcript proved that statement not to be true. The now 57-year-old wom-

an is appealing to the governor to commute her sentence to second degree murder and make her eligible for parole.

It is certainly easy to find sympathy for this woman's predicament, as was obviously felt by Maura Dolan, the reporter who wrote the newspaper story. However, I also had some other thoughts. There does not seem to be any question about the woman's guilt; some man was murdered and deprived of who knows how many years. How is that to be atoned? Certainly this woman must bear her share of the penalty for the wrong she did; maybe the number of years she has spent in jail represents the number of years lost by the man? I also could not understand why, when the woman was almost eligible for parole, she chose to have the case retried? What was to be gained? If there is a need to spread some blame around, what about the questionable advice that her lawyers provided to her? It was curious to me that no action was being filed against them challenging their legal practices.
