#### Saturday, February 24th We're Going To The Nethercutt!

J. B. Nethercutt, a Mason and Past Master (1947) of Santa Monica Lodge No. 307, was the cofounder of Merle Norman Cosmetics. In 1974 he built a museum in Sylmar, California, which he named "San Sylmar," to house his wife's and his various collections.

On Saturday, February 24th Ionic Composite will be touring San Sylmar and the Nethercutt Collection. We will view automobiles dating from the early 1900's to the late 1950's. On display will be perfectly preserved Dusenbergs, restored and Delahayes, Maybachs and other vehicles. We will see and hear the world-class mechanical collection of pianos, nickelodeons, cylinder & disc music boxes, orchestrions and the "Mighty Wurlitzer theatre pipe organ.

After touring San Sylmar, Ionic Composite will spend a few minutes wandering among the rest of the collection then gathering at the 1912 Pullman Private Car #100 "California," previously owned by Clara Baldwin Stocker, the eldest daughter of Santa Anita Race Track founder, E.J. "Lucky" Baldwin.
