



FROM THE WEST

As I hope everyone knows by now, on March 4, we will be celebrating the 49th annual Reception of the Grand Master of Masons in California, the Most Worshipful Stuart A. Wright. What some of you may not know is that the day before our Reception, the Grand Master will be attending the annual Men's Breakfast honoring him at the Los Angeles Airport Hilton put on by the Masonic Service Bureau of Greater Los Angeles. This event is considered to be the largest gathering of California Masons other than the Annual Communication and is attended not just by our Grand Master, but by his Officers Line and all of the leaders of the many concordant and appendant Masonic bodies.

I'm sure that many of you are unaware of the Bureau, let alone the many important functions it performs, other than throwing a major event every year, that is.

Service bureaus are organized pursuant to Part 11 of the California Masonic Code and may be formed by Lodges pursuant to a compact agreed upon among themselves with the approval of the Grand Lodge or Grand Master. Our own service bureau was founded in 1881, being originally called the Los Angeles Masonic Board of Relief.

The most obvious, if not the most important, responsibility of service bureaus is to make investigations requested by Lodges of this or any other Jurisdiction. Lodges are required to investigate every new applicant for the Degrees and for dual or plural membership by affiliation. Pursuant to CMC section 804.29, this investigation must include notifying every Lodge within 10 miles of its meeting place of the name, address and occupation of every applicant and provides that this duty may be fulfilled by a Masonic Service Bureau which operates under the direction and supervision of the Grand Secretary a clearing house for applications in the area in which the Lodge is situated. As a member of the LAMSB, this is how our Lodge complies with this mandate.

To relieve the distressed is a duty incumbent on all men, but particularly on Masons. This was the basis upon which service bureaus were founded. Service bureaus provide relief, when proper, to Masons of Lodges of this or any other Jurisdiction, as well as their widows and orphans, while residing or visiting in the area assigned to their assigned area. Of course, the Mason's Lodge is expected to reimburse the Bureau for these expenses.

Service bureaus also visit sick sojourning Masons and arrange and conduct funerals for Masons residing or visiting in the area assigned to their assigned area when their own Lodge is unable to do so. Our service bureau also provides California Masons with information about the services offered by the Masonic Homes and Masonic Outreach Services.

our service bureau also provides many additional services to the Craft. Each year it hosts a reception for the Deputy Grand Master so he can share his vision for the future with the Brethren. We provide a yearly forum for a detailed discussion of the legislation that will be voted upon at the upcoming Annual Communication of the Grand Lodge so its members can intelligently exercise their ballots on your behalf. Our service bureau also provides support to our Youth Orders and the Midnight Mission. Our service bureau is also a central location for sojourning brethren to call for meeting times and locations of Lodges and related Masonic groups and hosts a bulletin board for notifying Lodges in the area of upcoming events.

A s always, we look forward to seeing you in Lodge: Not just at stated meetings and degrees, but at all our social and educational events.

THINK ABOUT IT

Deneen Kuhlman worked at Desert Hot Springs High School as a financial clerk for 20 years, from 1997 to 2017. During that time, she embezzled almost \$350,000. This prolonged theft was discovered during a routine audit in late 2017. Shortly after that, she sent a letter to the school principal in which she confessed to the crime and then was hospitalized because of a suicide attempt. In December 2017, she did resign her position and, as a condition for that resignation, she agreed to pay back the full amount, making payments of \$300/month. Interestingly, and not explained in the newspaper story, she initially paid back more than she agreed, namely \$20,000.

In January 2019, she appeared in court for final sentencing. At that time, her attorney told the judge that Ms. Kuhlman, whose salary was about \$46,000 per year, had been struggling financially and only spent the money on necessities such as food and medical bills. He also noted that she had a child with special needs. To quote him, "At some point, the guilt was so overwhelming – this is coming from a woman with no records whatever, who is loved and respected in the community – and she decided to confess what she had done."

The lawyer's arguments apparently fell on a judge's friendly ears. Ms. Kuhlman was

sentenced to five years of probation, thereby not having to spend any time confined behind bars. She still has to pay back the remaining money from the theft, even though the school district has filed an insurance claim for the loss. She was instructed to find another job and to return to court in six months, at which time, the monthly payments would probably increase.

Ms. Kuhlman is probably fortunate that I was not the judge. Assuming that she still owes \$330,000, it would take almost 92 years to pay off that debt at \$300/month. Even if she could continue to pay \$20,000 per year, the payback would take over 16 years. Furthermore, both of these calculations assume that there would not be any additional interest or correction for inflation. A rationale that she needs to be home to care for her special needs child seems belied by her effort to commit suicide. Given her proclivity to steal, I wondered who would be willing to hire her and at what salary? Finally, her "overwhelming guilt" seems closely tied chronologically to her being caught.

From my perspective, it appears that Ms. Kuhlman will escape any incarceration for her crime and will likely die before she pays all of the debt back. For her, crime did pay.

Think about it.
