

#### FROM THE WEST

IWhy do Freemasons end their prayers with the phrase "So mote it be"?

It is customary amongst the monotheistic religions to end prayers with a hearty "Amen," ("Amin" in Arabic) a word meaning "So be it." Thus a congregation saying "Amen" is literally saying "So be it." The word "mote" is an archaic verb that means "may" or "might," and traces back to Old English. The phrase "So mote it be" means "So may it be," which is the same as "So be it."

Having established the equivalence of "Amen" and "So mote it be," the question remains, "Why do Masons end their prayers with 'So mote it be'?" The answer may well go back to the Regius Poem of about 1390 AD, the oldest known Masonic document (now housed in the British Museum, London). It is one of the Old Charges or Gothic Constitution used by

early Freemasons to regulate their trade. It has a legendary history, regulations to guide the Mason trade and rules of manners and moral conduct. The poem ends famously with this couplet: "Amen! Amen! So mote it be! So say we all for charity."

Thus Freemasons today end their prayers the same way they did in 1390. The next time you're in lodge and say "So mote it be" after the Chaplain finishes a prayer, remember that you are continuing a 600-year-old Masonic tradition.

#### THINK ABOUT IT

The following details about recycling come **▲** from an article written by James Rainey in the January 13, 2020 issue of the Los Angeles Times. Because of concerns about the environmental impact of discarded containers, many years ago the California legislature passed a law mandating buyers of canned or bottled drinks to pay a deposit fee. The money would then be refunded when the container was returned. Recycling centers were opened around the state because the recycled metal and glass could be resold at a profit. Unfortunately, over time, the price for the recycled material dropped and the cost of operating the recycling centers rose, due in part to increasing rents as well as other legislation raising the minimum wage.

Over half of these centers have closed and people living in many areas of the state have no convenient place to take their empty containers. A person living in Malibu has to drive to Inglewood. San Francisco has four centers to service 900,000 people. Many cities have no centers. While a portion of the law required the selling store to provide the refund, those places usually refuse to do so. Adding to the problem is that many of the stores that do redeem them just dump the containers someplace. The state has estimated that only 68% of the deposits have been claimed. The money

that was not returned (about \$450 million last year) is held by the state; while some of that money is subsequently returned to the stores mandated to pay the redemption fee, the current fund still contains over \$300 million.

**C**o we now are faced with a conundrum. A Dlaw passed with good intentions has increased the cost of the beverages while still leaving a significant residual of containers in the environment. Curiously, one action being considered by the state legislature is to pass a new law that extends the deposit fee to wine and liquor containers and requires the manufacturers and distributors of all of the covered beverages to produce a workable recycling plan (something that the legislature could not do). I do not understand how either component of this proposed legislation addresses the root causes of the problem, but it does appear that it would further raise the cost of the beverages as well as the amount of money that the state would then receive. I fear that this represents an example of government believing that one can solve problems created by previous laws by passing new laws.

Think about it.
