#### THINK ABOUT IT

Crises can often bring out the best in people. We have seen countless such examples during the COVID-19 pandemic. We have seen people taking care of elderly neighbors by doing their shopping or even just inquiring about how they are doing. Volunteers are spending their money, and, perhaps more importantly, their time preparing and delivering food and other necessities to the poor and homeless. One of the most dramatic examples was an Italian doctor who continued to take care of COVID-19 infected patients even after he ran out of personal protective equipment and was ultimately fatally infected himself.

Unfortunately, sometimes crises also bring out the worst. Consider two "concierge doctors" in the Los Angeles area. Concierge doctors charge their patients a premium, often in the thousands of dollars annually, in order to be allowed to keep having medical care. In exchange, the patients presumably gets more personal and timely attention.

Astory in the March 23, 2020 Los Angeles Times cited these doctors by name. One is a pediatrician in Santa Monica and the other a primary care physician in Beverly Hills. Both of them obtained the COVID testing kits early in the outbreak. The primary care physician obtained "rapid tests" (which were blood tests, not nasal swabs) that have been used in Asia; he planned to open a drive-through facil-

ity for anybody willing to pay \$5-600. The pediatrician has ordered hundreds of cheek-swab testing kits and is charging \$250 for each one.

These doctors seem to be justifying their ac-**L** tions by claiming that they are just providing good care to their patients. Of course, to an outsider, it does have the appearance of providing good care to their bank accounts. As a physician myself, I viewed the actions of these doctors as being indefensible from an ethical perspective. More importantly, I was not convinced that any particularly good care was being provided. If a doctor is going to provide tests to patients just because they want them, are they also going to provide prescriptions (such as antibiotics) or even surgeries for that reason as well? Healthcare workers, not patients, should make medical decisions; the patient can then agree or disagree with that decision.

As far as I could tell, these tests had not yet been approved for use by the FDA. The reason medical tests need FDA approval is that we need to know how accurate they really are. Damage can occur both when a test is falsely negative (and the patient goes on to spread infection) and when it is falsely positive (and the patient undergoes needless interventions such as quarantine).
