### **Important: New Grand Lodge Dues Procedure**

#### **Updated 12/20/2020**

By now you have received your 2021 dues notice from Grand Lodge.

You may pay Grand Lodge directly either by check or credit card.

If you choose to pay via Visa or Mastercard, a processing fee will be included in your payment.

- 1. Once posted, payments will be updated on the member's record in iMember 2.0. **Members may then immediately access their virtual dues card.\*** Secretaries will be able to see that they've made their payment through a special dashboard. And for lodges using Intacct, that system will also be automatically updated.
- 2. Every month, lodge secretaries will receive a check from Grand Lodge and an itemized report for all of funds collected, minus any credit card processing fees.

Of course, members are also welcome to pay their dues directly to their lodge secretary via cash, check or PayPal, who will record the payment in iMember 2.0 manually.

\* You must be registered in iMember 2.0 to get your dues card online. Please go to <a href="www.member.freemason.org">www.member.freemason.org</a> to register. You will need your member number which is on your current dues card. Once enrolled you will be able to download this app to your mobile phone.

## THINK ABOUT IT

The International Institute of Los Angeles (IILA) is a non-profit organization that was formed in 1914 to provide assistance to immigrants who are trying to integrate themselves into a new environment. For many years it was located in a Spanish Revivalist building in East LA. However, that building became too expensive to keep up, so the IILA moved its headquarters to Lincoln Heights. It planned on selling the old building and had received offers as high as \$5 million.

Local preservationists were concerned that the building would be torn down, as had other such structures in the area. In order to prevent the building from being irreversibly lost, they applied to the city to have it declared a historical monument. The application was approved by the appropriate city commission and the vote will be occurring soon in the City Council. Unfortunately, because of the more limited use potential of buildings so designated, the offers for its sale have decreased to no more than \$2 million.

The IILA, which never participated in this application, is opposed to such a designation because of the loss of revenue and the two sides are now contesting the entire issue. Officials of the IILA have noted that their job is to help immigrants, not buildings. The preservationists have argued that the IILA should use the building for fundraising and that the building really belongs

to the community. This story was described by a local reporter, Gustavo Arellano, who viewed the situation as a fight in which both sides were right and, at the same time, both sides were wrong. His solution was for both sides to stop fighting and instead combine forces to identify a buyer who would be sympathetic to the building and would even overspend to preserve the purposes of both the IILA charity and the neighborhood historical need.

This conundrum struck me as a demonstration of the conflict that often arises in our current political world between progressives who tend to look to governmental actions to solve problems (often a solution rooted in the philosophies of socialism) and conservatives who tend to look to individuals for those answers (usually a solution based on the principles of capitalism). I assumed that the reporter comes from the former camp, but I fear that his ideal buyer does not exist. Had he come from the other camp, his (perhaps equally unlikely to succeed) answer would have been for the preservationists to take responsibility for the selling price deficit by conducting their own fundraising to pay the IILA the difference in that price.
