Dear Brethren,





## THINK ABOUT IT

Bill Cosby was known as "America's dad" for decades until revelations about his interactions with a number of women became public several years ago. At that time, society again learned the difference between image and reality. In 2018 Cosby was sentenced to serve 3-10 years in a Pennsylvania state prison for drugging and sexually assaulting Andrea Constand in 2004. Apparently some of the evidence used against him in his trial was his own admission, given as part of a deposition in a civil suit filed by Ms. Constand.

In June 2021 the Pennsylvania Supreme Court not only overturned the conviction, but barred any retrial on the charges. The basis for this decision was a promise made in 2005 by the District Attorney of Montgomery County, Pennsylvania, Mr. Bruce Castor, not to file any charges. Ms. Constand had reported the incident to the police and it was investigated, but, according to Mr. Castor, there was not enough evidence to prove the accusation beyond a reasonable doubt even though he believed Ms. Constand's story. His decision not to file charges was designed to prevent Mr. Cosby from citing his Fifth Amendment right in the civil action. He believed that this decision would "get some justice for Andrea Constand". Mr. Cosby did admit in a deposition taken for the civil suit that he had given qualudes (a type of sedative) to women to try to have sex with them. Ms. Constand settled her case for over \$3 million.

Years later, a different District Attorney decided to charge Mr. Cosby and subsequently convicted him of sexual assault on Ms. Constand. The Pennsylvania Supreme Court ruled that the original promise by Mr. Castor was a valid one, so charges should never have been filed. That court found that, when a prosecutor unconditionally promises not to prosecute and a defendant relies on that promise to his detriment, fundamental fairness requires that the promise be enforced. While the ruling only applies to the Constand case, it is unlikely that any other charges will be filed because the statute of limitations has run out in those cases.

Needless to say, there has been an uproar about this ruling, especially in the #MeToo community. Since Mr. Cosby did admit to the behaviors for which he has been accused, it is easy to understand this anger. However, Mr. Cosby paid a civil settlement and spent about 3 years in prison before the conviction was overturned, so he has already suffered some penalty. More importantly, his claim of innocence will never be accepted by society and, like O.J. Simpson, he is likely to spend his remaining years being viewed as a social pariah by most people. Perhaps those protesting this court ruling should get past their anger and be satisfied that Mr. Cosby's life has been ruined.
