THINK ABOUT IT

David Lazarus writes a business column for the Los Angeles Times. He recently commented on a decision made by Delta Airlines to charge COVID-19 unvaccinated workers an additional \$200 per month for their health coverage. The company estimated that each case of COVID cost \$50,000 and that, by declining the vaccine, those employees were creating an additional financial risk. Mr. Lazarus recognized the logic of a decision to have people who are more likely to get sick pay more for health insurance. However, he then went on to observe that this philosophy represents the top of a dangerous and slippery slope. After all, he pondered, where should it end?

Many medical ethicists would agree that it is inappropriate to make sick people pay more, viewing healthcare as an inherent human right. In their eyes, health insurance is not comparable to auto, fire, life, or almost any other type of insurance, situations where such coverage is almost always priced based on the risk(s) that the insuree faces.

Having spent a career in medicine, I avoided this problem entirely by working in a public hospital, where payments and/or having insurance were never issues for patients. Of course, I then had to deal with a different conundrum, namely managing the costs of healthcare. In the case of COVID-19, however, the price of vaccination is not the reason why some Delta employees decided not to obtain one, but that decision did create economic problems for their employer. Why shouldn't they pay for that choice?

Mr. Lazarus worried about the slippery slope of a practice that forces individuals with chronic illnesses to pay higher insurance and other healthcare costs, but he included in those illnesses ones that are related to unhealthy lifestyle habits such as smoking. Even in these circumstances, he believed that "turning the screws on the sick or potentially sick…is just bad public policy". He concluded that penalizing the sick or potentially sick was "inhumane".

In addition to the value of compassion, another value comes into play, namely personal responsibility. People do have to be responsible for the decisions that they make and even for adverse situations that are out of the realm of their decision making. While society can (and, in many cases, should) provide assistance, society cannot fix all of the ills that befall people. If we have to draw a line somewhere (i.e., put up a barrier on the slope to prevent further falling), one place to start would be to provide less support for those who choose to get into trouble. Such a policy seems logical, not inhumane.
