
When was the Hundred Years War fought, who fought in it, and who won?

THINK ABOUT IT

Amy Glancy is a fourth-grade teacher in San Diego. In an effort to incorporate the school's curricular focus on understanding history from a non-white perspective, she decided to read a short poem by Countee Cullen entitled "Incident". The poem described the impact that an 8-year-old boy felt when another youngster stuck his tongue out at him and called him what is currently referred to as the "N-word". However, as soon as Ms. Glancy spoke that specific word, one of her students said "I can't believe you did that!" and walked out of class, followed by another student and a third one, while staying in the room, told her "You don't understand how hard it is to hear that word". Ms. Glancy has been temporarily suspended from her teaching duties.

This incident became the subject of a column by Sandy Banks in the Los Angeles Times. The column was entitled "Teacher's good intentions don't excuse N-word" and "The N-word doesn't belong in a fourth-grade classroom". Much of her column recalled her personal experiences of being hurt whenever the word was used. She attached the adjective "menacing" to describe the word and referred to a student of hers who used it as "clueless". Interestingly, there was little mention of the use of the same word by some current Black entertainers.

With that background, I would like to provide the wording of the poem: "Once riding in old Baltimore, heart-filled, headfilled with glee,

I saw a Baltimorean keep looking straight at me. Now I was eight and very small, and he was no whit bigger,

And so I smiled, but he poked out his tongue, and called me 'Nigger'.

I saw the whole of Baltimore from May until December;

Of all the things that happened there that's all that I remember."

For me, this was an extraordinarily good example of how a word can be harmful and an excellent segue to beginning a discussion about the problems that its usage can create. Although Ms. Banks believes that 8 and 9 year-old youngsters do not have sufficient emotional and intellectual development to handle such a discussion, her opinion loses sight of the fact that they are already old enough to feel the negative impact to the point where not only sticks and stones, but also names, can hurt.

A subsequent letter to the editor questioned the wisdom of suspending the teacher, as that action suggests that the listeners are victims and "helpless in the face of this magical word". Furthermore, the issue is not the word itself, but rather the context in which it is used. My worry is that, if we are going to punish people for using the N-word, then shouldn't we punish them for using other derogatory ones, such as the F-word (fat), the S-word (stupid), or the H-word (hate)?
