Dear Brethren,

Masonry has always put a strong emphasis on education, especially public education, because we have always understood that for a Democratic society to be possible, the public must be educated to at least certain basic levels. Furthermore, as a Fraternity predicated on the ideal of self-improvement, it has always been understood that education is one of the principle ways in which we can improve ourselves. To learn is to grow.

In today's world, perhaps more so now than ever before, knowledge truly is power. A teacher, therefore, is someone who literally empowers students by arming them with both knowledge and the tools by which to gain more. Most highly successful people can point back to at least one influential teacher or educator in their past who guided them or especially moved them in some important way or at a crossroads in their life. I myself can think of several right off the top of my head, and I am still in contact with at least 2 such individuals to this day.

Today, society is seeing a major downward trend in literacy and writing skills in graduating high school seniors. Part of this is no doubt related to technological trends (why bother to write a formal letter when you can use shorthand in a text or a tweet, never mind the use of emoji's), but part of it is, in my opinion at least, due to a societal shift in the way we treat educators. This is especially true of Elementary educators, who have the dual job of helping socialize and shape young boys and girls, as well as attempt to instill in them a love of learning at an early enough age that they will be able to flourish as they mature.

It was for this reason that at our September Stated meeting, we were planning on presenting awards to teachers and classified employees from two different Elementary schools. However, when speaking with the principals of the schools in advance of the event, something that still boggles my mind occurred: not one, not two, but three separate schools turned us down at the last minute. Two of the schools didn't even offer an explanation as to why; the principals simply declined our offer of both awarding teachers and employees annually as well as adopting the schools on an ongoing basis. The third school cited a concern that "teambuilding" efforts might be hurt if the school appeared to honor one teacher as being "better" or more "extraordinary" than all the others, never-mind the fact that numerous ways of selecting the honorees were put forward, including random selection, and it was stressed that everyone would eventually win.

This last reason strikes me as being a place they could certainly learn from the Masons. Part of our code is rejoice in one another's successes rather than be jealous or bitter when we are not personally selected for a given award or honor. Not "winning" is not the same as "losing", and society needs to be reminded of that. Likewise, we understand that in order for people to be motivated to go above and beyond, exemplary effort, achievement, and dedication must be recognized. Finally, we understand that when we as Masons see a brother honored for extraordinary service or accomplishment, it can and should act to motivate each of us to strive to greater lengths ourselves.

On that note, at our October Stated Meeting, we will be honoring the long dedication and service of two brothers of our own Lodge to the Fraternity by presenting Worshipful Bob Sills and Brother Sheldon Lodmer with their 50 year Golden Veterans awards. Most Worshipful Mel Stein, Past Grand Master, will be presenting the awards. I hope to see a big turnout for these dedicated brothers at Lodge.

## THINK ABOUT IT RON KORETZ, P.M.

We recently celebrated Labor Day but, in California, it was highlighted largely by labor dispute. In fact, in an Associated Press article by Adam Beam, it was called a "summer of discontent". We had the long-lasting strikes by the screen writers, actors, and hotel workers as well as a threatened one by nurses at Kaiser and a one-day walk-out by city workers. Now the State Legislature has entered the fray as it is considering a bill submitted by State Senator Anthony Portantino to make strikers eligible for unemployment compensation.

My understanding of how the unemployment program was supposed to function was that it provided a partial financial supplement for up to 26 weeks to people who, through no fault of their own, lost their jobs. This clearly was the case during past recessions and the recent COVID epidemic, when many businesses closed. I am less sure that I understand how people who go on strike are viewed by Sacramento politicians as having lost their jobs through no fault of their own. These people on strike voted for the strike; in other words, they chose to lose their jobs.

Labor unions have asserted that workers earn unemployment benefits while they are on the job. However, the unemployment funding is provided by employers only; unlike social security, the workers do not have any money taken out of their paychecks. In the past, the unions have set aside funds for such eventualities as part of the dues that the members pay. However, that responsibility does not seem to be borne by the unions any longer.

Further complicating the situation is the fact that the amount of money provided by employers is no longer sufficient to support the unemployment expenses we are currently encountering. The federal government actually loans the states the money to pay unemployment benefits and the states are expected to pay that money back. Mr. Beam reported that California currently owes the federal government over 18 billion dollars (largely from money loaned during the COVID pandemic) and that it will take a decade to pay off that debt and the accumulated interest. In the meantime, it was estimated that current benefit payments will exceed monies collected by over one billion dollars. This increasing debt has occurred in spite of three years of "record job growth", a phenomenon that has never before been seen during a period of job growth (according. to the Legislative Analysts's Office). Adding more recipients will certainly not make that burden lighter for the state.

One solution to resolving this debt is to increase the taxes that employers pay on behalf of their workers. Currently the tax only covers the first \$7000 that any employee makes, although the state recently imposed an additional \$21 per employee. Unions and some legislators note that the average employee in California makes \$67,000 per year, so the tax should have a higher earnings cutoff. Of course, simple economics tells us that such an increase will ultimately be passed on to the consumer.

Actions have consequences, and the actors have to assume the responsibility for those outcomes. Strikes almost always have adverse effects on the general public, ranging from interferences in traffic to more limited goods and/ or services. Strikes have side effects for the strikers as well, namely reductions in income. Making things easier for the latter group will not result in less discontent in future summers.

Think about it.
